- A. Downeast Diesel repaired hoist bracket and line on lower town dock hoist.
- B. Attended Maine Basic Harbormaster Association Training and received certification.
- C. Attended Maine Shellfish Warden Basic Training and received certification.
- D. Began purchasing items needed for Shellfish Warden duties (clam rings, boots,)
- E. Sent clam rings to be certified by Bureau of Weights and Measures
- F. Posted Mooring Waitlist as per state law. The list is posted on entrance door window to Harbormaster office.
- G. Met with Chalmers to get mooring inspection reports. Updated records in online mooring for moorings that they service. Will begin notifying mooring permit holders who need their gear inspected.

- A. Anne Napier
 - 1. Spent the last few weeks investigating harbor master office.
 - 2. Sturdy-built
 - a) 10x20 building = \$20k plus delivery
 - b) Solid and well built by her evaluation.
 - c) Spoke to the factory in Smyrna, ME
 - (1) Asked for 8'x15', insulated roof, side, and floor; 3' exterior door, paneled inside, siding outside, 5 windows = \$
 - (2) Also, another Amish builder in Unity (Tim Yoder, Backyard Builders)
 - (a) Backyard Builders Quote (Same as #1) = \$13,458.76
 - 3. Heat pump = \$800
 - 4. Composting toilet system = \$133-250
 - 5. Pad: could be done by public works
