The Applicant shall submit a project key plan and site plan. Plans for new buildings and/or structures are also required. Eight (8) copies of plans sized 8 1/2' x 11' 0" or 11' x 17' shall be submitted with site review application. A **Key Map** must show the entire project; its relationship to surrounding properties; and names of the property owners. A **Site Plan**, drawn to scale not less than one (1) inch equals forty (40) feet, or a scale acceptable to the CEO or Planning Board, shall include the following as applicable.
